Board Members in attendance:

Welcome from Jean -What we discuss here stays here. Let's try hard to work together and be respectful to each other, and not interrupt and talk over people.

First, copies of the November 2019 and January 2020 DIA meeting minutes were distributed by DIA President Jean Ryan (Jean) to the members of the DIA Board present. The Board members reviewed the minutes. Board member Carr Massi (Carr) moved for the Board to accept the November 2019 DIA meeting minutes and Board member Luda Demikhovskaya (Luda) second the motion. The Board members present voted unanimously to accept the November 2019 DIA meeting minutes. Board member Kathleen Collins (Kathleen) moved for the Board to accept the January 2020 DIA meeting minutes and Board member Joe Floccari (Joe) seconded the motion. The Board members present voted unanimously to accept the January 2020 DIA meeting minutes.

DIA Treasurer Phil Beder (Phil) gave the Board copies of the financial report and informed the Board that the backup documents were available at the meeting for the Board members' inspection. Phil stated that the total deposits were \$376.36, which he stated was a small amount, and the total withdrawals were \$291.44, which \$150 was to Verizon for DIA's telephone line and the remaining \$141.44 was to Staples for membership cards, notice cards, card stock and labels. Cathy moves DIA reimburse DIA's Treasurer Phil Beder for the \$141.44 he paid to Staples for membership cards, notice cards, card stock and labels was made, seconded and unanimously approved by the Board.

Phil suggests that DIA do a mailing to all members of DIA about membership dues and Jean agreed with this recommendation. Phil informed the Board that he filed DIA's 990, this is the 1040 IRS Form for non-profits with income less than \$50,000. Phil recommended that Board members assist him so we can all become familiar with how DIA's finances work.

Reminder: do not leave board papers on the table when the meeting is over.

Also, there was a discussion about the cost of the DIA telephone line and possible alternatives, such as a cell phone or, as suggested by Michael Ring (Michael Ril), a Google phone line which directs calls. saving money for what we have now have with Verizon and managed by Bob Schoinfeld (Bob) who's not on the board. Incoming calls are free on a Google line, but outgoing calls cost money. Further, we would probably have to get a different telephone number and it seems that you cannot have an answering message machine on a Google phone line (these beliefs need to be verified with Google). Finally, Jean explained that Bob, who answers DIA's telephone line has been doing it for many years, is

very knowledgeable and has done an excellent job. The Board agreed to keep the telephone line as is for now while other alternatives are investigated further.

Set up board training date. We will try again. Most board members are available Sunday March 8th. Saturday March 7 is a lesser maybe.

Finance Comittee meeting March 22 and April 26, 11:15am at Selis. It will be 45 minutes before the board training or 45 minutes before the DIA March meeting. Location to be announced. Discuss.

Committees - I'm appointing Kathy, Phil, Philip and Jean to the bylaws committee. They must be amended, we will meet by phone.

We will ask building management for a meeting on July 19th.

July 12 parade next Sunday.

There will be a big ADA celebration on the 26th of July. No details are available yet.

Phil: man from Amalgamated bank to help us financially get stuff including sound equipment Carr suggests we invite Victor Calise to next meeting to talk about ADA celebrations and spread information to the community about the census.
